Public Statement

I got to hear the extremely shocking news of the destruction of Jina-idols in Shri Pavagadh Tirth. The active efforts of the Learned Panyas Pravar Shri Jinpremvijayji Maharaj Saheb to peacefully pressurize the government and protect the Tirth are indeed appreciative. Wholehearted wishes that the efforts catalyse positive results for the Shasan.

It is imperative that the Jain Sangh awakens to protect the sanctity and prestige of the Tirths of the Jain Shwetambar Murtipujak Sangha. Many protective efforts have been undertaken from time to time for Shri Shatrunjay, Sametshikharji, Kesariyaji etc. Mahatirths, but the desired satisfactory outcomes have not been achieved. Some time ago, there was wave for safeguarding Shatrunjay and Sametshikharji Mahatirth. Millions of Jains showed their enthusiasm to protect these Tirths by joining the rallies in many Indian cities. Coincidently, I too was in Surat at that time. I accepted the request to auspice the rally. No satisfactory remedial steps have been taken here too. The situation of Kesariyaji Mahatirth has been heartbreaking and the Jain Sangh is still in the dark and unaware of what we have lost in Girnarji Mahatirth.
